

**ARTICLES OF AMENDMENT**

**ARTICLE I**

The name of this Corporation is **FIRST COMMUNITY CHURCH OF DADE CITY, FLORIDA, INC.**

**ARTICLE II**


The following amendment was adopted by a unanimous vote of the congregation, which is sufficient for approval, gathered at a special meeting on January 16, 2005, called for the purpose of considering such amendment.


The text of the amendment adopted by the congregation is as follows:

Upon the dissolution of **FIRST COMMUNITY CHURCH OF DADE CITY, FLORIDA, INC.** the assets shall be distributed for one or more exempt purposes within the meaning of Section 501 (c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be disposed of by the Court of Common Pleas of the County in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

**WHEREFORE**, the undersigned has executed these Articles of Amendment on this 10th day of January, 2005.
