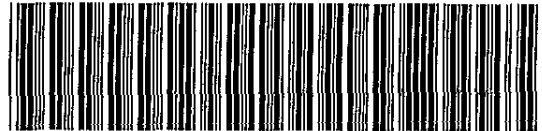



The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I

Name

The name of the Corporation shall be *BOBCAT CHESS CLUB, INC.*

ARTICLE II

Principal Office

The principal place of business and mailing address of this Corporation shall be *876 Division Street, Oviedo, FL 32765*. The Corporation may change the location of its registered office and mailing address from time to time without amendment of these Articles of Incorporation.

ARTICLE III

Purpose(s)

The specific purpose for which the corporation is organized is/are: *to operate a chess club for the students attending Oviedo area schools.*

ARTICLE IV

Manner of Election of Directors

The manner in which the directors are elected or appointed is that the number of Directors of this Corporation shall be the number from time to time fixed by the Shareholders, or by the Directors, in accordance with the terms and conditions of the Bylaws, but at no time shall said number of Directors be less than one.

## **ARTICLE V**

The initial registered agent of the Corporation shall be *Robert A. Juliano* and the Florida street address shall be *876 Division Street, Oviedo, FL 32765*. The Corporation may change its registered agent from time to time without amendment of these Articles of Incorporation.

### **Amendment**




