ARTICLE 1 - NAME

ARTICLE III – PURPOSE & SPECIFIC PURPOSE

The purpose of this corporation is organized exclusively as a charitable, and educational organization, within the meaning of Section 501 (C) (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States of Internal Revenue Law.

The specific purpose is to provide housing for pre-adult students who are coming out of the Foster Care System, and provide them with a secondary education, that will instruct them in the life skills that they need to make them a conscientious and productive member of society.
