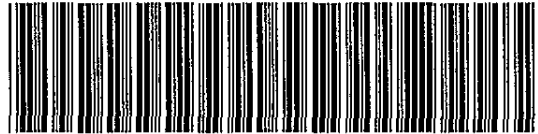

**ARTICLE I – NAME**

**ARTICLE II – PRINCIPAL OFFICE**

**ARTICLE III – PURPOSE & SPECIFIC PURPOSE**

The purpose of this corporation is organized exclusively as a charitable, and educational organization, within the meaning of Section 501 (C ) (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States of Internal Revenue Law.

The specific purpose is to provide housing for pre-adult students who are coming out of the Foster Care System, and provide them with a secondary education, that will instruct them in the life skills that they need to make them a conscientious and productive member of society.

**ARTICLE IV –MANNER OF ELECTION**

The initial Board of Directors were appointed by the President, for the term of one (1) year. The Board of Directors may be re-elected, and additional directors elected at the first annual meeting.

The initial Board of Directors will consist of four (4) directors. The number of directors may be increased or decreased by amendment of the Bylaws, but, shall in no case be less than four (4) directors.
