houses of worship now constructed or that may hereafter be constructed on said
promises hereby conveyed, the seats shall be forever free; and in further trust
and confidence that the said trustees and their successors in office shall permit
at all times the preachers who may be duly authorized according to the Book of
Discipline of the said Free Methodist Church, to hold religious services in said
houses of worship according to said Book of Discipline.
