

**ARTICLES OF INCORPORATION
OF
(TC)², INC.**

The undersigned, all of whom are citizens of the United States, desiring to form a corporation, not for profit, under the provisions of Chapter 617 of the Florida Statutes, do hereby certify:

FIRST: The name of said corporation shall be (TC)², Inc.

SECOND: The place where the principal office of the corporation is to be located at 1304 N. E. Davis Street, Lake City, Columbia County, Florida and its mailing address is P.O. Box 3508, Lake City, FL 32056-3508.

THIRD: The purposes for which the corporation is formed are as outlined below or as may hereafter, from time to time, be amended including:

- (a) Working exclusively for charitable, religious, educational, and scientific purposes.
- (b) Receiving, holding, and disbursing gifts, bequests, and funds arising from all sources.
- (c) Acquiring, owning, and maintaining real estate, buildings and other property real or personal, incidental, necessary, or proper to carry out said objects.
- (d) Doing of any and all things necessary or incident to the accomplishment of such purposes.

FOURTH: The following persons shall serve as the initial trustees and board of directors of said corporation and shall serve as provided in the Bylaws of the (TC)²:

The method of electing these trustees or, the terms and conditions of their service shall be as set forth in the corporation by-laws.

FIFTH: (TC)², Inc.'s Nondiscriminatory Policy is, as follows: (TC)² admits students and others of any race, color, national and ethnic origin to all the rights, privileges, programs and activities generally accorded or made available at the center. It does not discriminate on the bases of race, color, national and ethnic origin in administration of its educational policies, admission policies, scholarship and loan programs and other programs it administers.

SIXTH: The corporation, in conformity with the Bylaws of (TC)², shall have the power to receive, acquire, and hold title, in trust or otherwise, to real and personal property, and to improve, encumber, lease, sell, convey, and dispose such property.

SEVENTH: No part of the net earnings of the corporation shall inure to the benefit of or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the Third Article hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

EIGHTH: In addition to the powers and duties granted to this corporation by the Bylaws of (TC)², the corporation assumes for itself all the rights, powers and privileges and immunities which are now, and which may be during the existence thereof be conferred by law upon

corporation with a similar character, provided the same are not inconsistent with said Bylaws. Notwithstanding the above, however, at no time shall any of the amendments, bylaws, or regulations of the corporation be prohibited by or in conflict with the nonprofit corporate laws of the State of Florida.

NINTH: Membership is limited to the Board of Directors who shall be selected from a list of volunteers comprised of a cross section of the community that will be served by the (TC)².

TENTH: If for any reason the corporation shall be abandoned, discontinued, or cease to exist as a legal entity and its charter shall expire or be terminated, the title to all its property both real and personal shall be distributed to an organization qualified under 501 (c)(3) of the Internal Revenue Code of the United States, to receive it.

ELEVENTH: CERTIFICATE OF DESIGNATION OF REGISTERED AGENT/REGISTERED OFFICE: PURSUANT TO THE PROVISIONS OF SECTION 617.0501, FLORIDA STATUTES, THE UNDERSIGNED CORPORATION, ORGANIZED UNDER THE LAWS OF THE STATE OF FLORIDA, SUBMITS THE FOLLOWING STATEMENT IN DESIGNATING THE REGISTERED OFFICE/REGISTERED AGENT, IN THE STATE OF FLORIDA.
