# ARTICLES OF INCORPORATION SECRETARY OF STATE TALL AHASSEE, FLORIDA

The undersigned, for the purpose of forming a not for profit corporation under Chapter 617, Florida Statutes, does hereby adopt the following Articles of Incorporation:

#### **ARTICLE I: NAME**

The name of the corporation is ATLANTIC BREEZE CONDOMINIUM ASSOCIATION, INC.

#### ARTICLE II: PRINCIPAL OFFICE
