Pursuant to the provisions of Section 617.1006, Florida Statutes, the Articles of Incorporation, as amended, of Ice 2 Condominium Association, Inc. (the "Corporation") shall be amended as set forth herein.

1. Article 1 of the Corporation's Articles of Incorporation shall be deleted in its entirety and a new Article 1 shall be as follows:

**ARTICLE 1.  
NAME.**

The name of the corporation shall be **ELEMENT CONDOMINIUM ASSOCIATION, INC.** For convenience, the corporation shall be referred to in this instrument as the "Association," these Articles of Incorporation as the "Articles," and the By-Laws of the Association as the "By-Laws."

2. Article 3 of the Corporation's Articles of Incorporation shall be deleted in its entirety and a new Article 3 shall be as follows:

**ARTICLE 3.  
PURPOSE.**

The purpose for which the Association is organized is to provide an entity pursuant to the Florida Condominium Act as it exists on the date hereof (the "Act") for the operation of that certain condominium located in Miami-Dade County, Florida, and known as **ELEMENT, A CONDOMINIUM** (the "Condominium").

3. The foregoing amendment was adopted on August 16, 2005 by the joint written consent of the sole member and all of the members of the Board of Directors of the Corporation.
