ATTACHMENT TO THE ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF SHREE YOGESHWAR CHARITABLE FOUNDATION, INC.

Article III (Purposes), section (b) of the Articles of Incorporation of Shree Yogeshwar Charitable Foundation, Inc. is hereby amended by deleting said section (b) in its entirety and replacing the same as follows:

- (b) The specific purpose of this Corporation shall be to directly and indirectly support and provide assistance and basic necessities to the world's underprivileged, which includes but is not limited to:
- (i) providing educational assistance, medical assistance, and basic necessities to underprivileged individuals, particularly children, and making grants to organizations furthering such purpose;
- (ii) providing assistance to refugees and other displaced and/or marginalized individuals:
- (iii) providing medical assistance and treatment to and for injured and at-risk animals and making grants to organizations furthering such purpose; and
