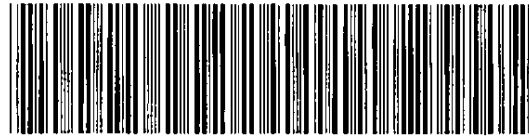

LESBIAN, GAY, BI-SEXUAL, AND TRANSGENDER ISSUES

Outreach Church of Christ Written In Heaven affirms the intrinsic and inherent worth of all people! Because God is the creative-Father of all people, all people have basic, innate worth. This includes those who are Lesbians, Gays, Bi-Sexual, and Transgender.

We are opposed to any and all forms of hatred and violence against Lesbians, Gays, Bi-Sexual, and Transgender individuals.

However, the Bible teaches that same-sex intercourse is sin (Romans 1:26-27; 1 Corinthians 6:9-11). We understand that to disagree in any way with the prevailing culture norm and opinion that same-sex intercourse is natural and normal is to be considered antiquated and bigot, we must lovingly stand where we believe the Bible stands.

The Bible appears relatively disinterested in sexual orientation. It is not what a person feels, but what that person does with those feelings is the Bible's concern.

Therefore, we do not believe that one's sexual orientation is sinful, whether that orientation is due to genetic causation or the complex interplay of genes, intra-uterine and post-uterine biological development, environment, and choice, which is our position.

We believe the grace of God is sufficient to overcome the practice of same-sex intercourse.

We hold that the practice of same-sex intercourse and biblical morality are incompatible.

We teach clear biblical standards for sexual morality, in general.

We will not permit the practice of same-sex intercourse by any leader of **Outreach Church of Christ Written In Heaven**.

We will invoke the appropriate discipline and reconciliation up to and including removal from leadership.

While we believe this standard is also applicable to members of **Outreach Church of Christ Written In Heaven**, the size of the church and the teaching that teachers or leaders incur a stricter judgment (James 3:1) is the reason for not assertively applying these measures to members.

MARRIAGE, DIVORCE, AND REMARRIAGE

The institution of marriage was conceived and established by God (Genesis 1:27; 2:18; 2:21-14; Ephesians 5:21-33; Colossians 3:18-21). It is older than any other institution. Furthermore, marriage is God's example to us of the relationship He desires with His bride, the Church. The **Outreach Church of Christ Written In Heaven** believes marriage to be a sacred and enduring relationship between one man and one woman.

Outreach Church of Christ Written In Heaven does not sanction, endorse, or recognize domestic partnerships, civil unions for same sex marriages and will not perform such services under any circumstances.

Based on Matthew 19:9; 5:32 and its contexts, we believe divorce to be granted on three grounds; abandonment, abuse, or adultery (which includes but is not limited to infidelity, incest, pedophilia, same-sex intercourse, and bestiality). (For further explanation see *Divorce and Remarriage in the Bible: The Social and Literary Context* and *Divorce and Remarriage in the Church: Biblical Solutions for Pastoral Realities*, by David Instone-Brewer.)

We will recognize divorces and perform remarriage services for those who have met the aforementioned grounds, as reviewed by the Elders.
