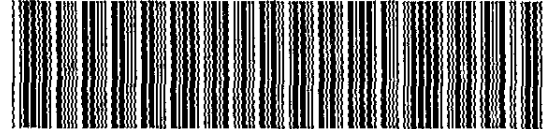

On behalf and with the authority of the charitable association known as The Tampa Bay Futures Golf Association, the undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a Not-For-Profit Corporation under the laws of the State of Florida.

**ARTICLE I - NAME**

The name of the Not-For-Profit Corporation so formed is:

**ARTICLE II - ADDRESS**

**ARTICLE III - PURPOSE**

The Tampa Bay Futures Golf Association, Inc., a Not-For-Profit Corporation, will devise, coordinate and carry out activities to support The Tampa Bay Futures Golf Classic for the purpose of raising monies to support charitable causes.

## **ARTICLE IV – NONPROFIT NATURE**

### **Section 1**

The Tampa Bay Futures Golf Association, Inc., a Not-For-Profit Corporation, shall operate exclusively as a non-profit educational and charitable organization in accordance with Section 501(c)(3) of the United States Internal Revenue Code of 1986, or the corresponding provision of any subsequent or future United States Internal Revenue Law. Notwithstanding any other provision of these Articles, The Tampa Bay Futures Golf Association, Inc., a Not-For-Profit Corporation, shall not carry on any activities not permitted to be carried on by an organization exempt from Federal Income Tax under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended.

### **Section 2**

No part of the net earnings of The Tampa Bay Futures Golf Association, Inc., a Not-For-Profit Corporation, shall inure to the benefit of any private shareholder or individual. No substantial part of the activities of The Tampa Bay Futures Golf Association, Inc., a Not-For-Profit Corporation, will include the carrying on of propaganda, or attempt to influence legislation, or participation or intervention in any political campaign on behalf of any candidate for public office.

## **ARTICLE V - EXISTENCE**

The Tampa Bay Futures Golf Association, Inc., a Not-For-Profit Corporation, shall have perpetual existence as a Not-For-Profit Corporation, unless terminated by law, dissolution or unforeseen circumstances.

## **ARTICLE VI - ELECTION OF DIRECTORS**

The Board of Directors shall be elected and shall govern in accordance with Florida law and the By-Laws of The Tampa Bay Futures Golf Association, Inc., a Not-For-Profit Corporation, as duly enacted and amended.

## **ARTICLE VII - INITIAL DIRECTORS**

The duly constituted Board of Directors of The Tampa Bay Futures Golf Association, Inc., a Not-For-Profit Corporation, serving at the time of incorporation hereby, who shall manage all of the affairs of the Corporation until the next duly scheduled election, are:
