**ARTICLES OF INCORPORATION
OF
International children Angel network Inc.**

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I NAME

The name of the corporation shall be: **International children Angel network Inc.**

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:
9155 S. Dadeland Blvd., Suite 1410, Miami, Florida 33156

ARTICLE III PURPOSES

The specific purpose for which the corporation is organized is: The purpose for this non profit organization is to provide financial help in the form of clothing, monies, and school supplies to the less fortunate children in the world. The foundation will first provide assistance to a non profit organization called Amigos Das Crianças ins Praia Do Forte Bahia in Brazil. This association provides shelter, schooling health (vaccinations etc.) for children of this village and its surroundings neighboring villages. The school was founded in late 1980's by Mrs. Edisar Ribeiro Pereira. The association has provided for the poor in this region for more than 50 years. Once we meet our goals of providing sufficient sponsor help to care for these children, we will reach other children in need.

This corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Notwithstanding any other provisions of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

No part of the net earnings of the organization shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purpose set forth in the purpose clause hereof. No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.


ARTICLE VI DISSOLUTION

Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the organization is then located, exclusively for such purposes.
