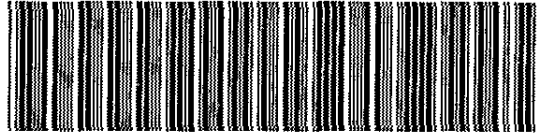

Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal of office of the organization is then located, exclusively for such purposes.
