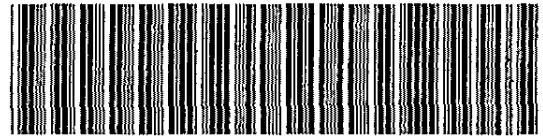

NAME AND ADDRESS**

- 1.00** The name of the corporation shall be T. F. GRAY COLLECTIBLES, INC.
- 1.01** The principal place of business and mailing address of the corporation is 1341 Riverside Circle, Wellington, FL 33414.

**ARTICLE II
DURATION**

- 2.00** The corporation shall have perpetual existence.
- 2.01** The date and time of the commencement of the corporation's existence shall be October 01, 2004.
