The undersigned, acting as incorporator(s) of a corporation pursuant to Chapter 617, Florida Statues, adopts the following Articles of Incorporation for such corporation:

ARTICLE I. NAME

The name of the corporation shall be:

ARTICLE II ADDRESS

It does not discriminate on the basis of race, color, national or ethnic origin in administration of its educational policies, admission policies, scholarship and loan programs, and other school -administered programs.

ARTICLE VI. MANAGEMENT OF CORPORATE AFFAIRS

ARTICLE VII. EARNINGS AND ACTIVITIES OF CORPORATION

No part of the net earnings of the corporation shall insure to the benefit of, or be distributed to its members, directors, officers to other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article V hereof.

Notwithstanding any other provision of these Articles, this corporation shall not, except to an insubstantial degree, engage in any activity or exercise any powers that are not in furtherance of the purposes of this corporation.

Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction in the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations as such court shall determine, which are organized and operated exclusively for such purposes.
