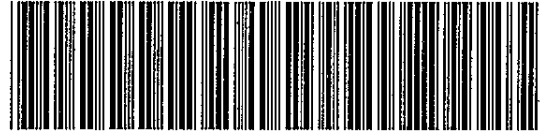

**Articles of Incorporation
for
Humanitarian Aid Needed for Dignity and Support, Inc.**

ARTICLE I - NAME

The name of this corporation is Humanitarian Aid Needed for Dignity and Support, Inc. and its principal place of business shall be located in County of Orange at 1506 Wise Avenue, Orlando, Florida 32806. The Corporation may have such other offices, either within or without the State of Florida, as the President may designate or as the business of the Corporation may require from time to time.

ARTICLE II – PRINCIPAL PLACE OF BUSINESS

Humanitarian Aid Needed for Dignity and Support, Inc.'s principal place of business shall be located in the County of Orange at 1506 Wise Avenue, Orlando, Florida 32806. The Corporation may have such other offices, either within or without the State of Florida, as the President may designate or as the business of the Corporation may require from time to time.

ARTICLE III- DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles of Incorporation with the Department of State of Florida.

ARTICLE IV- PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business. More specifically, one of the many purposes for which the corporation is organized is to raise money through grass roots fundraising, grants, corporate donations, other charitable appeals and through legislation. These funds shall be used to provide support to all organizations with particular emphasis on those whose purpose is to improve the quality of life and standard of living of people worldwide, but beginning with and focusing on Africa. A portion of what we seek is to offer this assistance through supportive efforts including, but not limited to medical care, education and community self-sufficiency programs.

ARTICLE V - INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of this corporation is 1506 Wise Avenue, Orlando, Florida 32806 and the name of the initial registered agent of this corporation at that address is Jonathan Pelikan.

ARTICLE VI – INITIAL OFFICERS

ARTICLE IX - INDEMNIFICATION

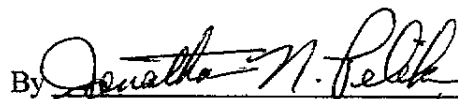

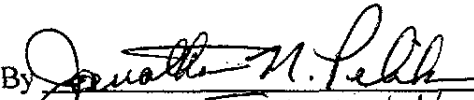
