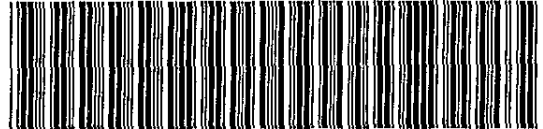

ARTICLES OF INCORPORATION OF
