To this end, corporation shall promote the mental, moral, and physical development of its members. The corporation will positively impact our community's future by providing quality youth development programs for disadvantaged boys and girls that nurtures and develops them into responsible citizens who enjoy and promote a healthy, drug-free lifestyle. All funds, whether income or principal, and whether acquired by gift or contribution or otherwise, shall be devoted to said purposes. Upon dissolution the assets of the Corporation shall be distributed exclusively to one or more charitable or educational organizations or to the federal government, or to a state or local government, for a public purpose.
