ARTICLES OF INCORPORATION FOR

Plantation Colonels Band Boosters, Inc.

A Not For Profit Corporation

Article I

The name of the Corporation shall be Band Boosters of Plantation High School, Inc.

Article II

The street address of the initial principal office shall be 2319 N Andrews Avenue, Fort Lauderdale, FL 33311 and the mailing address shall be 2319 N Andrews Avenue, Fort Lauderdale, FL 33311.

Article III

The purpose of the corporation is to be a not for profit corporation under Chapter 617, Florida Statutes, and to promote and support the band program at Plantation High School through fund raising, transportation and any other activity that would enhance and foster the band program, its members and Plantation High School.

Article IV

The Corporation shall have a minimum of three and a maximum of fifteen members of the Board of Directors. The manner in which the members of the Board of Directors are elected or appointed shall be set forth in the Bylaws of the Corporation.

Article V

The street address of the Corporation's initial registered office shall be 2319 N Andrews Avenue, Fort Lauderdale FL 33311 and the name of its initial registered agent at that address shall be Royale Management Services, Inc.

Article VI


ACCEPTANCE OF DESIGNATION AS REGISTERED AGENT
