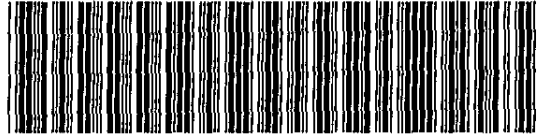

OF

ARTICLE I

Name: The name of the Corporation shall be "Access Florida Conference, Inc".

ARTICLE II

Principal Place of Business: The principal place of business and mailing address of the Corporation is 1711 S. Gadsden Street, Tallahassee, Florida 32301.

ARTICLE III

Purpose: The purposes for which the corporation is organized are exclusively charitable and educational within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

The activities of the corporation to promote such purposes include, but are not limited to the following:

- a) To engage in economic development activities that benefit Florida's Minorities.
- b) To promote and obtain private and public contributions to fund activities related to its purposes.

ARTICLE IV

Membership: The members of this Corporation shall be the Florida Black Business Investment Board, Inc. and the Florida State Hispanic Chamber of Commerce. The voting and other rights of such members shall be determined in accordance with the Corporation's bylaws.

ARTICLE V

Membership Certificates: Pursuant to Florida Statutes 617.041(3), the Corporation may issue membership certificates in the Corporation evidencing the amount of money contributed to the Corporation by any of its members. The Corporation shall not pay

Dividends to its Members.

ARTICLE VI

Officers/Board of Directors: The Board of Directors shall manage the affairs of the Corporation. Officers and members of the Board of Directors shall be elected or appointed in accordance with the Bylaws of the Corporation.

ARTICLE VII

Initial Directors/Officers: The name and addresses of those persons who are to act as directors until the election of their successors, and who shall constitute the number of directors of the Corporation until changed by the Bylaws are:

ARTICLE VIII

Initial Registered Agent: The name of the initial registered agent of the Corporation is Hilmon S. Sorey, Jr., and the initial registered office and mailing address is 1711 S. Gadsden Street, Tallahassee, Florida 32301.

ARTICLE IX

Incorporator: The name and address of the Incorporator is Hilmon S. Sorey, Jr., 1711 S. Gadsden Street, Tallahassee, Florida 32301.

ARTICLE X

Dissolution: Upon the dissolution of the Corporation, the Board of Trustees, after paying or making provision for the payment of all of the liabilities of the Corporation, shall dispose of all the accumulated net earnings of the Corporation exclusively for the benefit of either: i) one or more organizations which are themselves exempt as organizations described in sections 501 (c)(3) and 170 (c)(2) of the Internal Revenue Code of 1986 or corresponding sections of any prior or future Internal Revenue Code, or ii) to the Federal, State, or local government for exclusive public purpose

ARTICLE XI

Amendment to Articles: These Articles of Incorporation may be amended by the act of the Directors of the Corporation. Such Amendments may be proposed and adopted in a manner provided in the Bylaws of the Corporation.

Having been named as registered agent to accept service of process for the above stated corporation at the place designated in this certificate, I am familiar with and accept the appointment as registered agent and agree to act in this capacity.
