### ARTICLE I. NAME AND ADDRESS

MALLAHASSEE, FLORIDA

The name of this corporation is **HIBISCUS COURT CONDOMINIUM ASSOCIATION**, **INC.** For convenience, the corporation shall be referred to in this instrument as the "association", these articles of incorporation as the "articles", and the bylaws of the association as the "bylaws".
