ARTICLES OF INCORPORATION

In Compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I NAME

The name of the Corporation is SWINTON GARDENS HOMEOWNERS ASSOCIATION, INC., hereinafter called the "Association."

ARTICLE II PRINCIPAL OFFICE

The address of the principal office of the Association shall be 35 Swinton Gardens Drive, Delray Beach, Florida 33444

ARTICLE III PURPOSE

This Association does not contemplate any financial gain or profit, direct or indirect to the members thereof, and the specific purposes for which it is formed are to provide for or assure the maintenance and control of the Property within the jurisdiction of the Association, and to promote the health, safety and welfare of the Owners of the Property within the jurisdiction of the Association.
