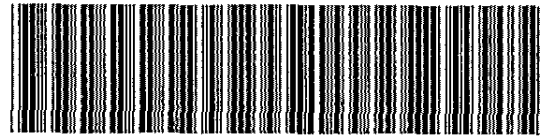

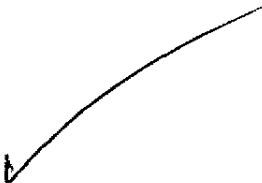

The undersigned incorporator, for the purpose of forming a Not For Profit Corporation under the Florida Business Corporation Act, Florida Statute, Chapter 617, hereby adopts the following Articles of Incorporation.

ARTICLE I- NAME



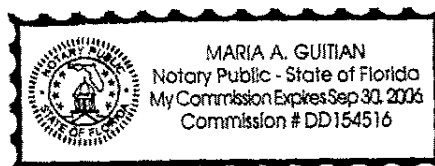
