

ARTICLES OF INCORPORATION

In Compliance with Chapter 617, *Florida Statutes* (Not for Profit)

THE WITHLACOOCHEE RENEGADES HUNT CLUB, INC.

ARTICLE I NAME

The name of the corporation shall be: The Withlacoochee Renegades Hunt Club, Inc.


