**ARTICLES OF INCORPORATION**

- Article 1:** The name of the corporation shall be the **FLORIDA ATHLETIC CLUB, INC.**
- Article 2:** The principal place of business and mailing address of this corporation shall be: 3250 Lakeview Blvd, Delray Beach, Florida, 33445-5607
- Article 3:** The purpose for which this corporation is organized is:
- a. To provide training, coaching and support for potential and established Olympic athletes;
  - b. To better the health and welfare of the community through clinics, coaching, athletic events, newsletters and articles;
  - c. To provide athletic opportunities for youngsters to prevent and fight juvenile delinquency;
  - d. To provide adults with recreational activities;
  - e. To foster community relations.
- Article 4:** Directors shall be elected by members of the Florida Athletic Club for a term of two years. Elections will be done by mail. Nominees shall be made between December 1<sup>st</sup> and January 15<sup>th</sup>. The names of the nominees shall be submitted to members in good standing. The tabulation of the votes shall take place thirty days from the date the names of the nominees were submitted. The Directors shall serve for two years. A Director may be removed by a majority of the Directors. Meetings of the Directors may take place by mail, Email, telephone, and/or in person. There may be as many as nine Directors. If a Director dies or resigns the remaining Directors shall appoint a replacement to complete the unexpired term.
