ARTICLE I

The name of the corporation shall be:

Florida Educational Research Association, Inc.

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:

ARTICLE III PURPOSE

The purpose for which the corporation is organized is:

To encourage and improve all aspects of educational research and its application, thereby increasing the contribution of education to human welfare. The term "educational research" shall be broadly construed, to include both theoretical and applied educational research, including educational evaluation, educational measurement, and institutional research.

MANNER OF ELECTION

The manner in which the directors are elected or appointed:

A Nominating Committee shall nominate one qualified person (member in good standing) for each of the three Director positions to be filled. The names of the nominees shall be mailed to all members in good standing with notice that additional persons may be nominated by petition. If any member in good standing is put forward for a Director position by petition of 10 or more members, that person shall be added as an additional nominee for that position. If no more than one person is nominated for a Director position, balloting shall not be necessary for that position; the Executive Committee of the organization shall then certify the election of the nominee at a meeting held prior to or during the Annual Meeting. If two or more persons are nominated for a Director position, election to that position shall be by secret mail ballot of the members in good standing. Ballots shall be returned to the Secretary, who shall deliver them sealed to the Teller Committee for counting. In a two-person contest the person receiving the largest number of votes shall be declared elected. If more than two persons have been nominated for a Director position, voting shall be by ranking, and election by allocation of votes in accordance with the Hare System.
