

## ARTICLES OF INCORPORATION OF MASSALINA COMMONS CONDOMINIUM ASSOCIATION, INC. a Florida corporation not for profit

The undersigned incorporator by these Articles associates himself for the purpose of forming a corporation not for profit pursuant to the laws of the State of Florida, and adopts the following Articles of Incorporation:

#### ARTICLE I, NAME

The name of this Corporation is Massalina Commons Condominium Association, Inc.

#### ARTICLE IL TERM OF EXISTENCE
