ARTICLES OF INCORPORATION

OF

**INTERFAITH/INTERAGENCY NETWORK
OF CHARLOTTE COUNTY, INC.**

A NOT FOR PROFIT CORPORATION

The undersigned under the laws of the State of Florida, do hereby subscribe to and adopt the following as our Articles of Incorporation:

ARTICLE 1. - NAME

The name of this corporation is **INTERFAITH/INTERAGENCY NETWORK OF CHARLOTTE COUNTY, INC.**

ARTICLE 2. - PRINCIPAL OFFICE

The principal office and mailing address of the Corporation shall be:
1750 Manzana Avenue
Punta Gorda, FL 33950

ARTICLE 3. - PURPOSE(S)

The Corporation is a charitable organization, organized for the purpose of proactively coordinating and developing resources so that disaster victims become and remain survivors.

No part of the Corporation's net earnings will inure to the benefit of any private shareholder or individual and it is not organized for profit or organized to engage in an activity ordinarily carried on for profit.

ARTICLE 4. - MANNER OF ELECTION OF DIRECTORS

The Corporation shall have three (3) Directors initially. The number of Directors may be either increased or diminished from time to time by the Board of Directors in accordance with the By-Laws of the Corporation.

ARTICLE 5. - INITIAL REGISTERED AGENT AND STREET ADDRESS

ARTICLE 7. - BY-LAWS

The Corporation shall be governed by the By-Laws.

The Board of Director(s) of the INTERFAITH/INTERAGENCY NETWORK OF CHARLOTTE COUNTY, INC. shall have the power to make, alter, amend or repeal the By-Laws of the Corporation, but with the affirmative vote of a number of Directors equal to a majority of the number who would constitute a full Board of Director(s) at the time of such action shall be necessary to take any action for the making, alteration, amendment, or repeal of the By-Laws.

ARTICLE 8. - EFFECTIVE DATE

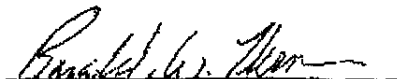
These Articles of Incorporation shall be effective immediately upon approval of the Secretary of State, State of Florida.

ARTICLE 9. - AMENDMENT

The Corporation reserves the right to amend, alter, change or repeal any provision contained in these Articles of Incorporation, or in any amendment hereto, or to add any provision to these Articles of Incorporation or to any amendment hereto, in any manner now or hereafter prescribed or permitted by the provisions of any applicable statute of the State of Florida, and all rights conferred upon shareholders in these Articles of Incorporation or an amendment hereto are granted subject to this reservation.

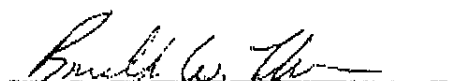
ARTICLE 10. - DISSOLUTION
