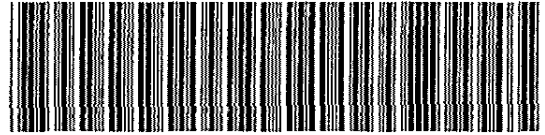

**ARTICLES OF INCORPORATION
OF
HARVEST TIME PENTECOSTAL CHURCH OF GOD, INC.**
(A corporation not for profit)

The undersign, for the purpose of forming a corporation for religious, charitable and philanthropic purposes, under the provisions of Chapter 617, Florida Status, acknowledge, and file the following Article of Organization.

ARTICLE I— NAME

The name of the corporation shall be HARVEST TIME PENTECOSTAL CHURCH OF GOD, INC

ARTICLE II— PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be 4000 Street West, Lehigh Acres, Florida 33971

ARTICLE III— PURPOSE

The general nature of the objects and purposes of this corporation shall be as follows, to – wit:

To carry on such activities and perform such services as are ordinarily conducted by churches and religious organizations of the Christian faith; to build, establish and maintain churches and Sunday Schools; to build, establish and maintain and conduct a Bible school and do all other things that incorporated religious organization may do under the laws of the State of Florida.

ARTICLE IV— MANNER OF ELECTION

The manner, in which the directors are elected or appointed, shall be by having an annual election with a 2/3rd majority of membership present and in good standing. The pastor, however, is elected indefinitely unless otherwise specified at the time of election.

ARTICLE V—INITIAL REGISTERED AGENT AND STREET ADDRESS

ARTICLE VI—DURATION

The corporation shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State. This corporation is to exist perpetually.


