ARTICLE I: NAME

The name of the corporation is: L AND C GROUP HOME, INC.

ARTICLE II: PURPOSE FOR WHICH ORGANIZED

The purpose for which the corporation is organized is:

A. To engage in any nonprofit activity permitted under the laws of the United States and of the State of Florida, and particularly for the operation on a nonprofit basis of an adult group home for the mentally and physically challenged.

ARTICLE III: INCORPORATORS

The method of election of the Board of Directors shall be as more particularly stated in the bylaws. The minimum number of directors that will be required to run the affairs of the corporation is three (3).


ARTICLE VI: REGISTERED OFFICE STREET ADDRESS

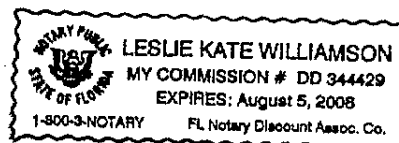


