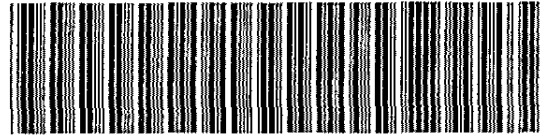

ARTICLES OF INCORPORATION
OF

We, the undersigned incorporators, hereby make, subscribe, acknowledge, and file with the Secretary of State of the State of Florida these Articles of Incorporation for the purposes of forming a corporation not for profit in accordance with the laws of the State of Florida.

ARTICLE I

Name

The name of this non-profit corporation shall be: FRIENDS OF TEMPLE TERRACE PARKS AND RECREATION DEPARTMENT, INC.

ARTICLE II

Principal Office

The principal office of this Corporation Shall be located at 6610 Whiteway Drive, Temple Terrace, Florida 33617, but the Corporation shall have the power to relocate its principal office to other places within Hillsborough County, Florida as may be determined and deemed expedient from time to time.

ARTICLE III

Purpose

a) The purpose of this Corporation shall be to secure funds by donation and fund raising activities to help obtain equipment or to support projects initiated by the City of Temple Terrace's Parks and Recreation Department.

b) The purposes for which the Corporation is organized are exclusively Charitable and educational within the meaning of Section 501 (c) (3) of the Internal

Revenue Code of 1954 or the corresponding provision of any future United States Internal Revenue Law.

c) Notwithstanding any other provision of these articles, this organization shall not carry on any other activities not permitted to be carried on by an organization exempt from Federal Income Tax under Section 501 (c) (3) of the Internal Revenue Code of 1954 or of the corresponding provision of any future United States Internal Revenue Law.

ARTICLE IV

Manner of Election

The Directors of the Corporation will be nominate by the membership and will be elected by a majority vote of the general membership at an annual meeting to be held within the first fifteen (15) days of the month of February. The three (3) Directors may be increased from time to time by the membership, but shall never be less than three (3) or more than fifteen (15). A Director may also be an officer of the Corporation. A Director may not serve for more than two (2) consecutive terms.

ARTICLE V

Initial Directors

The names and street addresses of the members of the first Board or Directors of this Corporation, who, subject to these Articles of Incorporation, by bylaws of this Corporation and the laws of the State of Florida, shall hold office, for the first year of the existence of this Corporation, are:

It shall be necessary for Directors to be members of the Corporation except that a representative from the Temple Terrace Parks and Recreation Department can be an honorary Director with no voting privileges.

Article VI

Initial Registered Agent

The Friends of the Temple Terrace Parks and Recreation, Inc., desiring to organize under the laws of the State of Florida, with its principal office as indicated in the Articles of Incorporation at the City of Temple Terrace, County of Hillsborough, has named RICKEY GIBSON; located at 901 West River Drive, Temple Terrace, Florida 33617, County of Hillsborough, State of Florida, as its agent to accept service of process within this state.
