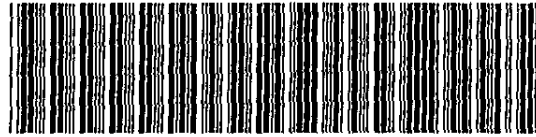

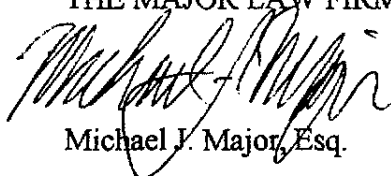

ARTICLES OF INCORPORATION
OF HEART FOR ZION MINISTRIES, INC., a non-profit corporation

ARTICLE ONE

Name of Corporation. The name of the corporation, in accordance with Chapter 617.0202 Florida Statutes, shall be **HEART FOR ZION MINISTRIES, INC.**

ARTICLE TWO

Principal Place of Business. The principal place of business and mailing address of the corporation shall be 1622 N.W. 19TH Lane, Gainesville, Florida 32605.

ARTICLE THREE

Specific Purpose. The specific purpose of this Corporation is promoting the message of the gospel of Jesus Christ by Heart For Zion Ministries, Inc. throughout the United States and around the world.

ARTICLE FOUR

Manner of Election of Directors. The Directors constituting the First Board of Directors of Heart For Zion Ministries, Inc. for the next two (2) years from the date of incorporation are hereby appointed and designated in Article Five in these Articles of Incorporation. Thereafter, Directors will be elected by a vote of two thirds (2/3) of incumbent directors in accordance with the Corporation's Bylaws.
