The undersigned incorporator to the Articles of Incorporation, a natural person competent

to contract, hereby forms a corporation under the laws of the State of Florida.

# **ARTICLE L NAME**

The name of this corporation shall be THE ENTELECHY FOUNDATION, INC.

# ARTICLE II. PURPOSE

The general purpose and plan of operation of this corporation shall be to support and facilitate activities, individuals and organizations that promote health, healing and/or selfrealization.

### **ARTICLE III. MANNER OF ELECTION OF DIRECTORS**

The terms of admission and qualification for membership in this corporation shall be by application, written or oral and approved by appointment by the Chief Executive Officer. Notwithstanding Clause. Notwithstanding any other provision of these articles, the 4. organization is organized exclusively for one or more of the purposes as specified in

Section 501 (c) (3) of the Internal Revenue Code of 1986, and shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under IRC 501 (c) (3) or corresponding provisions of any subsequent tax laws.

Inurement Clause. No part of the net earnings of the organization shall inure to the benefit of any member, trustee, director, officer of the organization, or any private individual (except that reasonable compensation may be paid for services rendered to or for the organization), and no member, trustee officer of the organization or any private individual shall be entitled to share in the distribution of any of the organization's assets on dissolution of organization.

Political/Legislative Clause. No substantial part of the activities of the organization shall be carrying on propaganda, or otherwise attempting to influence legislation (except otherwise provided by IRC 501 (h)) or participating in, or intervening in (including the publication or distribution of statements), any political campaign on behalf of or in opposition to any candidates for public office.

#### ARTICLE IX, AMENDMENTS

This corporation reserves the right to amend alter, change or repeal any provision contained herein in the manner now or hereafter prescribed by law.

#### ARTICLE X. DISSOLUTION

In the event of dissolution, all of the remaining assets and property of the organization shall after payment of necessary expenses thereof be distributed to such organizations as shall qualify under section 501 (c) (3) of the Internal Revenue Code of 1986, or corresponding provisions of any subsequent Federal tax laws, or to the Federal government or State or local government for a public purpose, subject to the approval of a Justice of the Supreme Court of the State of Florida.
