**Articles of Incorporation of
Hispanic Children's Cancer Caring Center, Inc.
A Florida Not-for-Profit Corporation**

The undersigned, a majority of whom are residents of the State of Florida, desiring to form a Not-for-Profit Corporation under the laws of the State of Florida, do hereby certify as follows:

Article 1. Name

The name of this Corporation shall be

Hispanic Children's Cancer Caring Center, Inc.

Article 2. Principal Office

This Corporation's principal office shall be initially located at

Article 3. Purposes

This Corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501 (c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. The specific purpose of the Corporation is to raise funds for Children's Cancer Caring Center, Inc., a Florida Not-for-Profit corporation, an exempt organization under Section 501 (c) (3) of the Internal Revenue Code.

Article 4. Directors

This Corporation shall have 3 directors. The initial directors' names and addresses are as follows:

Article 5. Limitations

a. No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, *except* that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article 3 hereof.

b. No substantial part of the activities of the Corporation shall be carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not engage in, or participate in, or otherwise intervene in (including the publishing or distribution of statements), any political campaign on behalf of, or in opposition to any candidate for public office.

c. Notwithstanding any other provision of these Articles, this Corporation shall not, *except* to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this Corporation.

Article 6. Dissolution

Upon the dissolution of this Corporation, its assets shall be distributed for one or more exempt purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed shall be disposed by the court of competent jurisdiction of the county in which the principal office of this Corporation is then located, exclusively for such purposes or to such organizations, as said court shall determine, which are operated exclusively for such purposes.

Article 7. Registered Agent

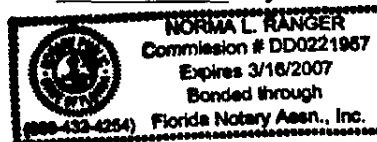
