ARTICLES OF INCORPORATION
OF

In compliance with the requirements of Chapter 617 of the Florida Statutes, the undersigners, being natural persons, do hereby act as subscribers in adopting and filing the following Articles of Incorporation. We the undersigned subscriber(s), hereby associate ourselves together, and make, subscribe, acknowledge and file with the Secretary of State of the State of Florida, this Certification of Incorporation for the purpose of forming a not for profit corporation in accordance with the laws of the State of Florida.

ARTICLE I.

The name of this corporation is Harmony Independent Baptist Church, Inc.

ARTICLE II.

The corporation shall have perpetual existence.

ARTICLE III.

The Harmony Independent Baptist Church, Inc. has all powers conferred by Florida Chapter 617, except as limited herein:

- A. The purposes for which the corporation is organized are exclusively religious, charitable, and educational within the meaning of Section 501 (c) (3) of the Internal Revenue Code of 1986 or the corresponding provisions of any future United States Internal Revenue law.

- B. Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under Section 509 (c)(3) of the Internal Revenue Code of 1986 or the corresponding provisions of any future United States Internal Revenue law.

ARTICLE IV.

The qualifications for members and the manner of their admission shall be regulated by the By-Laws.

ARTICLE V.

The number of directors will be established in the By-Laws. This corporation will be governed by the directors whose election shall be provided for in the By-Laws.

On dissolution or final liquidation, the Board of Directors shall, after paying or making provision for the payment of all the lawful debts and liabilities of the Organization, distribute all the remaining assets of the Organization to one or more nonprofit organizations created to succeed the Organization or having similar aims and objectives as the Organization, provided that each selected organization shall then qualify as an organization exempt from federal income taxation under section 501 (a) of the Internal Revenue Code of 1986 as an organization described in sections 501 (c) (3) or 501 (c) (4) of such Code (or relevant successor provisions).


