#### ARTICLES OF INCORPORATION FOR KATYDID CONCEPTS, INC.

The undersigned, acting as the authorized representative of a not for profit corporation to be formed under the Florida Not For Profit Corporation Act (the "Act"), Chapter 617, Florida Statutes (2003), as amended, hereby forms a Florida Not For Profit Corporation (this "Corporation") pursuant to the Act and hereby sets forth the following Articles of Incorporation (these "Articles"):
