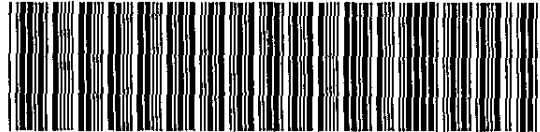

ARTICLES OF INCORPORATION

Article I - Name

The name of the corporation shall be DisasterSAFE Incorporated.

Article II – Principal Office

The principal place of business and mailing address of this corporation shall be 4693 North Monroe Street, Tallahassee, Florida 32303.

Article III – Purpose

The corporation is organized exclusively for any lawful purpose to retain nonprofit status as set forth in the most current Internal Revenue Code, and to act and operate exclusively as a nonprofit corporation pursuant to the laws of the State of Florida, its municipalities, county governments, and the United States.

The primary purpose of this corporation shall include, but not be limited to, educating the public about ways to mitigate disaster, both natural and manmade.

Article IV – Manner of Election

The number of directors constituting the initial board of directors of the corporation is four (4). They were appointed by the Incorporator to serve as directors until the first annual meeting or until their successors are elected. Directors of this corporation shall serve for a term of four (4) years and may be re-elected for successive terms by a majority vote of the board of directors, as stated in the By-Laws.

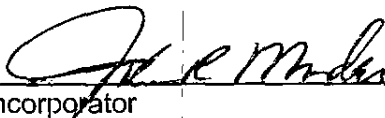
