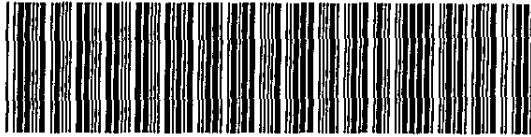

**ARTICLES OF INCORPORATION
OF
POINCIANA HEIGHTS HOMEOWNERS TASK FORCE, INC.
(A FLORIDA NOT FOR PROFIT CORPORATION)**

Article I

The name of the corporation is Poinciana Heights Homeowners Task Force,

Article II

The initial principal office of the Task Force is 1903 S. W. 5th Street, Ocala, Florida 34474.

Article III

The primary purpose of the Task Force is to coordinate and work with residents of the community and public officials and agencies to:

1. Rejuvenate the community through the enforcement of Florida State Statutes and City of Ocala Ordinances;
2. Restore to the community a standard of living and quality of life desired by its residents;
3. Work with public officials in the reduction and elimination of drug activity and other criminal activity; and
4. Promote the health, safety and welfare of the residents of the community.

Article IV

A Board of Directors, which shall consist of no less than five (5) or more than seven (7) members, shall manage the affairs of the Task Force. The board members shall also serve as the officers of the Task Force. The Board of Directors shall be elected annually by a majority vote of the resident members at the annual meeting of members.
