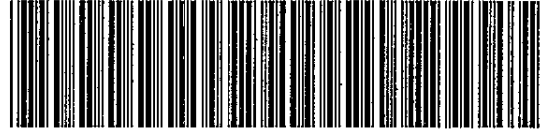

ARTICLES OF INCORPORATION  
OF  
NO MORE HOMELESS CATS, INC.  
A NONPROFIT CORPORATION

Articles of Incorporation of the undersigned, a majority of whom are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of Florida, do hereby certify:

**Article 1:** The name of the corporation shall be: No More Homeless Cats, Inc

**Article 2:** The place in this state where the principle office of the corporation is to be initially located is: 526 Orange Drive #33, Altamonte Springs, Florida, Seminole County.

**Article 3:** Said corporation is organized exclusively for the charitable, religious, educational, and scientific purposes, including for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501 (c)(3) of the Internal Revenue Code, or corresponding section of any future tax code. The specific purpose of No More Homeless Cats, Inc. is to operate a shelter for homeless and abused cats that provides adoption, counseling, humane education, and community outreach services to enrich the lives of people and cats.

**Article 4:** The Corporation shall have three directors. The initial directors' names and addresses are:

The Board of Directors shall be elected each year, by a majority of the votes of the current board.

**Article 5:** No part of the net earnings shall inure to the benefit of or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article 3 hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in ( including the publishing or distribution of statements), any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of the corporation.

**Article 6:** Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed shall be disposed of by a Court of Competent Jurisdiction of the county in which the

principle office of the corporation is then located, exclusively for such purposes or to such organizations, as said Court shall determine, which are operated exclusively for such purposes.

**Article 7:** The registered agent and registered agents office of this corporation are:

**Article 8:** The Corporation shall have no members.

**Article 9:** The period of duration of the corporation is perpetual.




