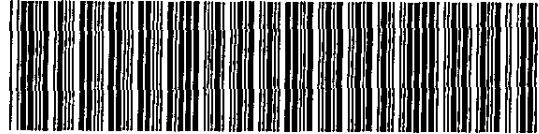

Article I Name: The name of the Corporation shall be Independent Order of Odd Fellows of the Harry Marsh Unity Inc.
