Article I

Article III

The Specific purpose for which this corporation is organized is:

The organization is organized exclusively for charitable and educational purposes under section 501 (c)(3) of the Internal Revenue Code, corresponding section of any future federal tax code.

This organization is also organized to prevent the abuse of children, adults and animals. To help provide love and care, facilities, education and a chance for a full and happy life for abused children, adults, and abused/homeless animals.

To provide funding for and assistance to organizations and individuals who provide for and help prevent the abuse of children, adults and animals and provide for their care and shelter. To provide funding for educational programs on abuse.

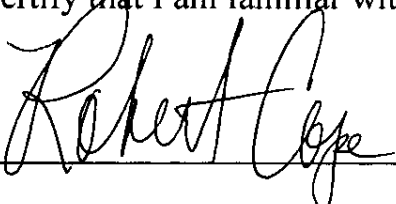

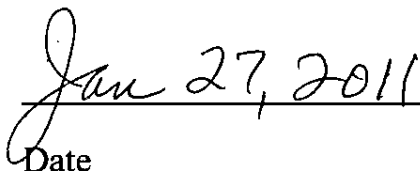

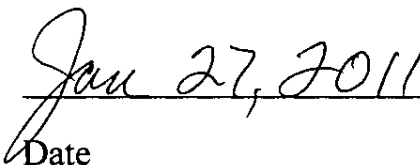

Amendments to Include:

ARTICLE VI

No part of the net earnings of the corporation shall insure to the benefit of, or be distributable to its members, trustees, officers,, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and make payments and distributions in furtherance of the purpose set forth in Article III hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition for public office. Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

ARTICLE VII

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purpose within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
