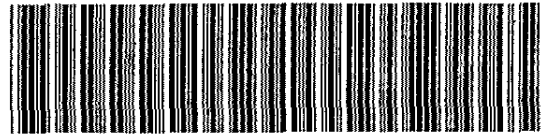

**ARTICLES OF INCORPORATION  
OF

The UNDERSIGNED, natural persons of legal age acting as incorporators of a not-for-profit corporation under Chapter 617 of the Florida Statutes, adopt the following Articles of Incorporation for such applicable corporation.

**ARTICLE I - NAME**

The name of this corporation is:

**ARTICLE II - PRINCIPAL ADDRESS**

**ARTICLE III - NATURE OF BUSINESS**

The purpose(s) for which this corporation is organized is (are):

To provide children and families with the opportunity to realize their full potential through education and recreation. We will target students in Orlando who come from disadvantaged circumstances that are performing below grade level and/or attend an "F" graded school.

Within this entity we will implement several programs that will address academic needs with an emphasis on reading and math and test taking strategies. We will also concentrate on drug and alcohol abuse, abstinence from sexual involvement, career training, computer literacy, health and nutrition, home economics, anger management, community service and performing arts because we believe that success and failure in a person's life can be affected by the presence of positive intervention during adolescent years.

- A. Notwithstanding any other provisions of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.
- B. Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of 501(c)(3) of the Internal Revenue Code of 1986, or corresponding section of any future Federal tax code, or shall be distributed to the federal, state, or local government for a public purpose. Any assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the organization is then located, exclusively for such purposes.

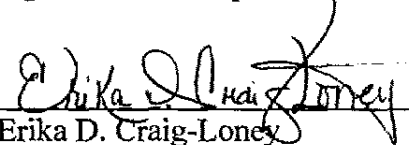
