ARTICLES OF INCORPORATION

OF

JESUS IS LIFE 35TH STREET CHURCH OF GOD, INC.

This Corporation is organized pursuant to the FLORIDA Non - Profit Corporation Codes, adopt the following Articles of Incorporation:

ARTICLE I - NAME

The name of this corporation shall be **JESUS IS LIFE 35TH STREET CHURCH OF GOD, INC.**

ARTICLE II - PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS

The principal place of business is **3437 Avenue "O", Riviera Beach, Florida 33404.** The mailing address of this corporation shall be **1622 W. Blue Heron Blvd. Riviera Beach, Florida 33404.**

ARTICLE III - PURPOSES

The specific purposes for which the corporation is organized are: providing a place of worship for its members, who shall be members in good standing of the Church of God, Cleveland, Tennessee, and conducting the affairs of the congregation according to the rules and regulations of the Church of God, Cleveland, Tennessee, and specifically the minutes of the General Assembly of the Church of God, Cleveland, Tennessee; *promoting the cause of Christianity in accord with the teachings, tenets, and customs of the church of God, Cleveland, Tennessee;* receiving managing and disbursing gifts, bequests and other funds for the benefit of the congregation and the Church of God, Cleveland, Tennessee; owning and maintaining suitable buildings and facilities, and doing all things necessary for their acquisition, upkeep, maintenance and sale, all in accord with the minutes of the General Assembly of the Church of God, Cleveland, Tennessee.

ARTICLE IV - MANNER OF ELECTION OF DIRECTORS

The manner in which the directors are elected or appointed is as follows: The affairs of the Corporation shall be governed by a Board of Directors. (Hereinafter referred to as the "Board") elected in accordance with the Bylaws, subject to the restriction that, except as specifically set forth to the contrary in the Bylaws, the exercise of any power or actions of the Board shall require the approval thereof by a majority vote of the Board present at a meeting at which a quorum of no less than two (2) Directors are present.
