ARTICLES OF INCORPORATION

OF

JESUS IS LIFE 35TH STREET CHURCH OF GOD, I

This Corporation is organized pursuant to the FLORIDA Non – Profit Corporation Codes, adopt the following Articles of Incorporation:

ARTICLE I - NAME

The name of this corporation shall be JESUS IS LIFE 35TH STREET CHURCH OF GOD, INC.

ARTICLE II - PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS
