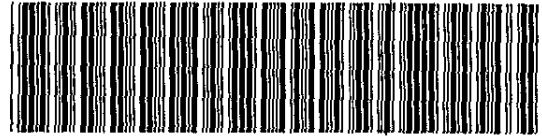

ARTICLES OF INCORPORATION

OF

IN HIS PRESENCE WORSHIP CENTER, INC.

The undersigned, acting as incorporator of a Corporation pursuant to Chapter 617, Florida Statutes, adopts the following Article of Incorporation of such corporation:

ARTICLE I

The name of the Corporation shall be IN HIS PRESENCE WORSHIP CENTER, INC. The principal place of business of this Corporation shall be 2810 Frankford Avenue, Panama City, Florida 32405.

ARTICLE II

The period of the duration of this Corporation is perpetual unless dissolved according to law.

ARTICLE III

The purpose for which the Corporation is organized is for religious purposes and is to be operated exclusively for such religious purposes as will qualify it as an exempt organization under Section 501(c)(3) of the Internal Revenue Code. In furtherance of this purpose, the Corporation may exercise any lawful powers under the law, including but not limited to those set forth in Chapter 617 of the Florida Statutes, as may be amended or superseded from time to time. The following is non-exclusive listing of the powers and obligations of the Corporation in furtherance of its purpose:

1. To conduct services of a religious nature, to establish and maintain a place (or places) of worship.
2. To bring people to a personal acquaintance with Jesus Christ through the proclamation of the Gospel.
3. To bear witness to all Biblical truth.
4. To solicit funds, collect monies, receive gifts and bequests, and otherwise raise money to fulfill the stated purposes.
5. To expend, contribute, disburse and otherwise handle and dispose of funds received.

6. To purchase, lease, rent, acquire, own, hold in trust, use, sell, convey, mortgage, or otherwise dispose of any real estate or chattels as may be necessary to hold in trust properties for the stated purposes.
7. To borrow money, issue bonds, debentures, notes or other obligations, in payment for property, or any of the purposes stated herein.
8. To govern itself according to this constitution and Bylaws adopted.
9. To establish Bible Colleges, Church Schools and other Churches both at home and abroad.
10. To establish and maintain such departments, institutions, and services for the propagation of the gospel, as needed.
11. To establish home meetings for the purpose of neighborhood evangelization, developing relationships among members, and providing spiritual oversight to church families.
12. Notwithstanding any other provision of these Articles, this Corporation will not carry on any activities not permitted to be carried on by (a) a corporation exempt from federal income tax under Section 501 (c) (3) of the Internal Revenue, or the corresponding provisions of any future United States Internal Revenue law of (b) a corporation, contributions to which are deductible under the Internal Revenue Code or any other corresponding provisions of any future United States Internal Revenue law.

#### ARTICLE IV

The number constituting the initial Board of Directors of the Corporation is three (3). The method of electing the directors is set forth in the By-Laws. The number of directors may be either increased or diminished from time to time in accordance with the Bylaws, but shall never be less than three (3). The names and addresses of the initial directors of this Corporation are as follows:

#### ARTICLE V

This Corporation is organized without members or shareholders with the Board of Directors possessing all power and authority that would otherwise vest in the members or shareholders.

#### ARTICLE VI

In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations which themselves are exempt as organizations described in Section 501(c)(3) of the Internal Revenue Code of 1954 or any corresponding section(s) of any prior or future law, or to the Federal, State, or Local Government for exclusively public purposes. No part of the net earnings of the organization shall inure to the benefit of, or be distributable to, its members, trustees, officers or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of this document, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or corresponding section of any future federal tax code.






