ARTICLES OF INCORPORATION

OF

WHITEHEAD STREET CONDOMINIUM ASSOCIATION, INC.

A FLORIDA CORPORATION - NOT FOR PROFIT

ARTICLE I. NAME AND ADDRESS

The name of this corporation is Whitehead Street Condominium Association, Inc.

For convenience, the corporation shall be referred to in this instrument as the "association", these articles of incorporation as the "articles", and the bylaws of the association as the "bylaws".
