**ARTICLES OF INCORPORATION
OF
HARLEM MCBRIDE AND N. E. 43RD STREET
NEIGHBORHOOD ASSOCIATION OF OAKLAND PARK, INC**

We, the undersigned incorporator, hereby make, subscribe, acknowledge and file with the Secretary of State of Florida, these Articles of Incorporation for the purpose of forming a Non-Profit Corporation in accordance with the laws of the State of Florida.

Articles I

The name of this Non-Profit Corporation shall be:

Harlem McBride and N. E. 43rd Street Neighborhood Association of Oakland Park, Inc.

Articles II

The principal office of this non-profit corporation shall be located at:

Article III

The general nature of the business to be transacted by this Non-Profit Corporation, or the objects and purpose of the corporation shall be:

The purpose of the Harlem McBride and N. E. 43rd Street Association, shall be to unify and promote the general welfare of all residents of the community, to insure an impartial and strenuous enforcement of uniform restrictions existing on such lands; to unify efforts in support of local authorities, to insure adequate police and fire protection; to cooperate and encourage the maintenance of quality education in public school in general are; to perform those acts calculated to maintain the value of property within such subdivision; to provide pleasant living conditions within the area; and to establish channels of communication among residents, so that they may speak with one voice on political, civic, and government issues / concerns.
