ARTICLES OF INCORPORATION

OF

Florida International Admittance Corporation,
a Non-Profit Florida Corporation

(Pursuant to Chapter 51, Florida Statutes)

These articles are adopted by the incorporators of the corporation as set forth in the following articles of incorporation and are hereby adopted as the articles of incorporation of the corporation.

1. Name. The name of this corporation shall be Florida International Admittance Corporation.

2. Purpose. The purpose of this corporation shall be to promote and maintain the health and welfare of the people of the State of Florida and to promote the economic development of the State of Florida. 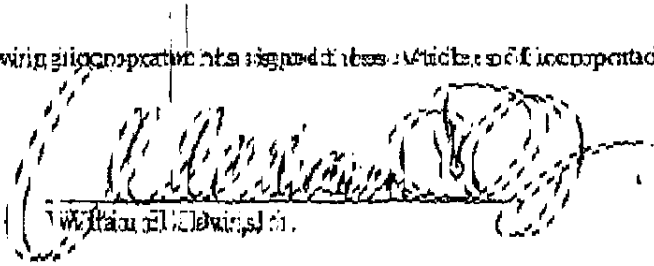
