

ARTICLES OF INCORPORATION

In compliance with, Chapter 617, f.s., (Not for Profit)

ARTICLE I – NAME

The name of the corporation shall be:

Kite's Family Services for Humanity, Inc.

ARTICLE II - PRINICIPAL OFFICE

Kite's Family Services for Humanity, Inc. 5303 Archstone Dr., #107 Tampa, Florida 33634



ARTICLE III – PURPOSE

The purpose for which the corporation is organized is:

To operate exclusively for providing social and religious services for the low to moderate income individuals and families. Providing affordable housing opportunities and assistance with job readiness and credit repair.

- A. The purpose for which this organization is organized are exclusively religious, charitable, scientific, literacy and educational within the meaning of section 501 (c) (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.
- B. Notwithstanding any other provisions of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal Income tax under section 501 (c) (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.
- C. Upon the dissolution of the organization, assets shall be distributed for one of more exempt purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code of 1986, or corresponding section of any future Federal tax code, or shall be distributed to the Federal, state, or local government for a public purpose. Any such assets not so disposed of by a court of competent jurisdiction of the county in which the principal office of the organization is then located, exclusively for such purposes.

ARTICLE IV – MANNER OF ELECTIONS

The manner in which the directors are elected or appointed

- 1. Board vacancies will be advertised and posted on the church bulletins offices of religious organizations and religious educational facilities, in the office of Children and Family Services and like agencies.
- 2. Resumes of interested candidates will be required.
- 3. Selections will be made from the resumes.
- 4. The existing board members will vote from the selected names.
- 5. The selected candidates will be notified by a written letter from the President of the board.
