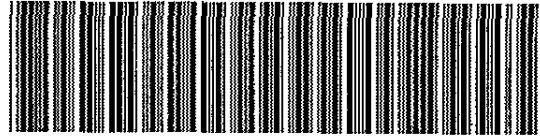

AMENDMENT TO ARTICLES OF INCORPORATION
FOR
BARTLEY REALTY SERVICES FOUNDATION, INC.

The following Article of the corporation, being duly approved and adopted by the members and board of directors, is hereby amended to provide as follows:

ARTICLE III

The specific purposes for which the corporation is organized are:

- A. The purposes for the corporation is organized are exclusively charitable and educational within the meaning of section 501(C)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.
- B. Notwithstanding any other provisions of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501(C)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.
- C. In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations which themselves are exempt as organizations described in sections 501(C) and 170(C)(2) of the Internal Revenue Code of 1986 or corresponding sections of any prior or future Internal Revenue Code, or to the State or local government for exclusive public purpose.
